SUMMARY OF OFFICER DECISION AND REASON FOR THAT DECISION	Immediate revocation of [REDACTED] licence following the receipt of a police disclosure detailing that [REDACTED] is currently on police bail. [REDACTED] was arrested after suspicious activity was noted and his vehicle was stopped and searched. The arrest was for the offence of being unfit through drink/drugs, possession of class b drugs and other unspecified driving offences. [REDACTED] did not notify Swale Licensing of his arrest which is a breach of the Swale Hackney Carriage (Taxi) and Private Hire Licensing Policy. [REDACTED] was not driving a licenced taxi/private hire vehicle at the time of the arrest. However this is a serious offence and in the interest of public safety the decision has been taken to revoke his Swale Dual Hackney/Private Hire Driver Licence with immediate effect.

This proposal was rejected, [REDACTED] has previously informed Licensing that he was not currently working as a taxi driver, but without revocation [REDACTED] could return to working as a licenced driver at any time therefore a delay in action would not be in the interest of public safety
