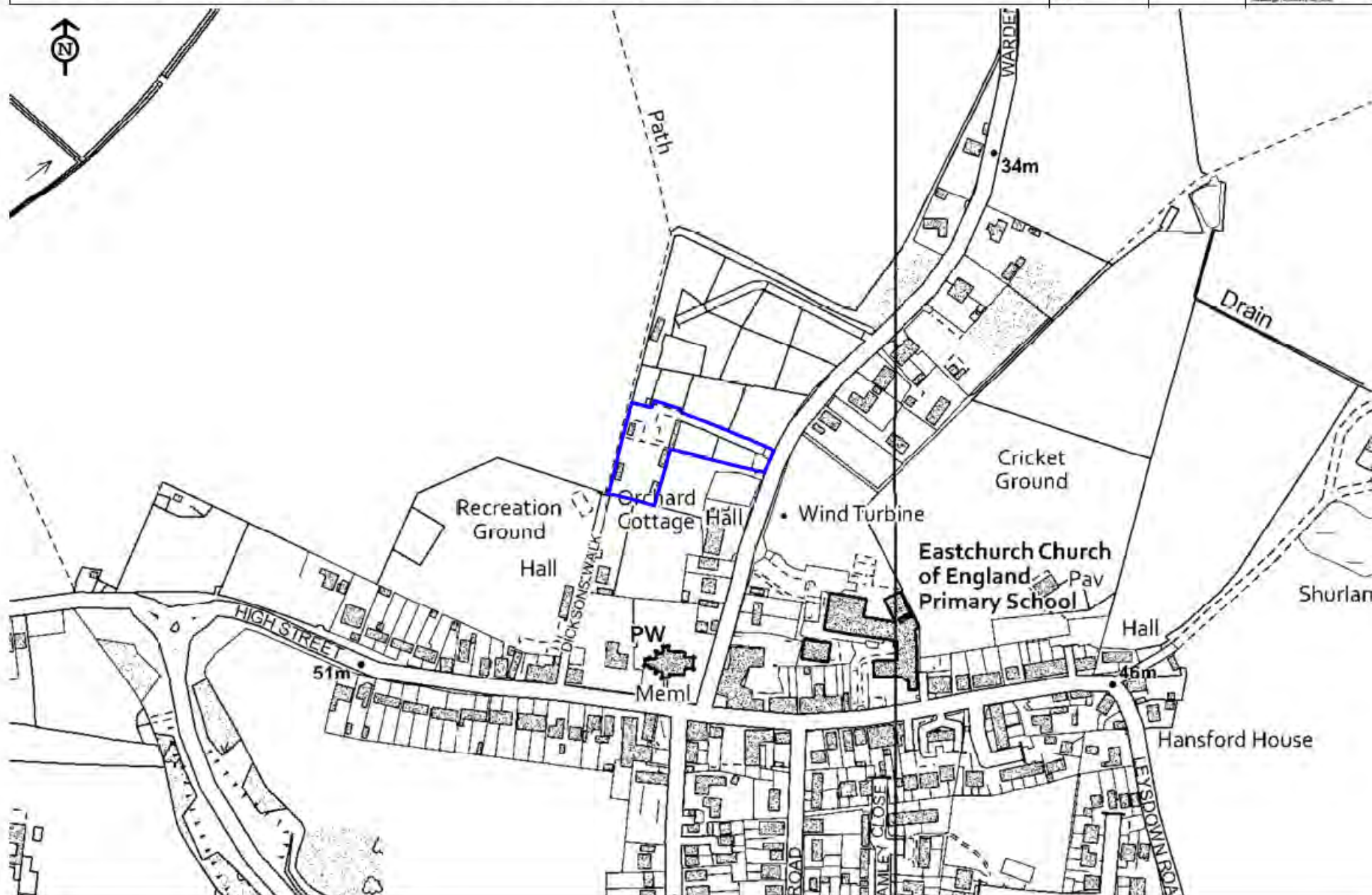


SHELAA/431 - Land at Warden Road, r/o Orchard Cott (Mary's Place), Eastchurch

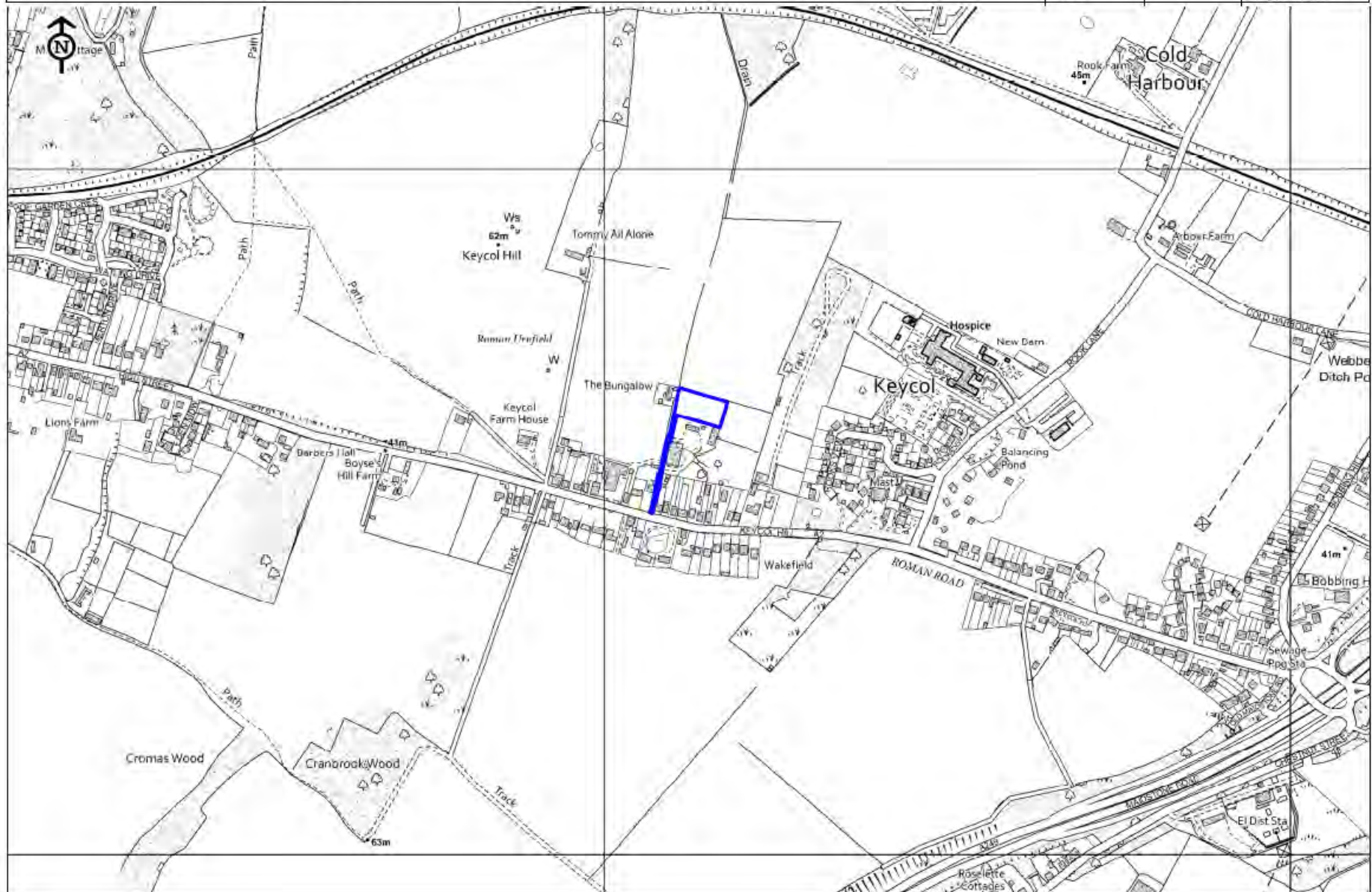

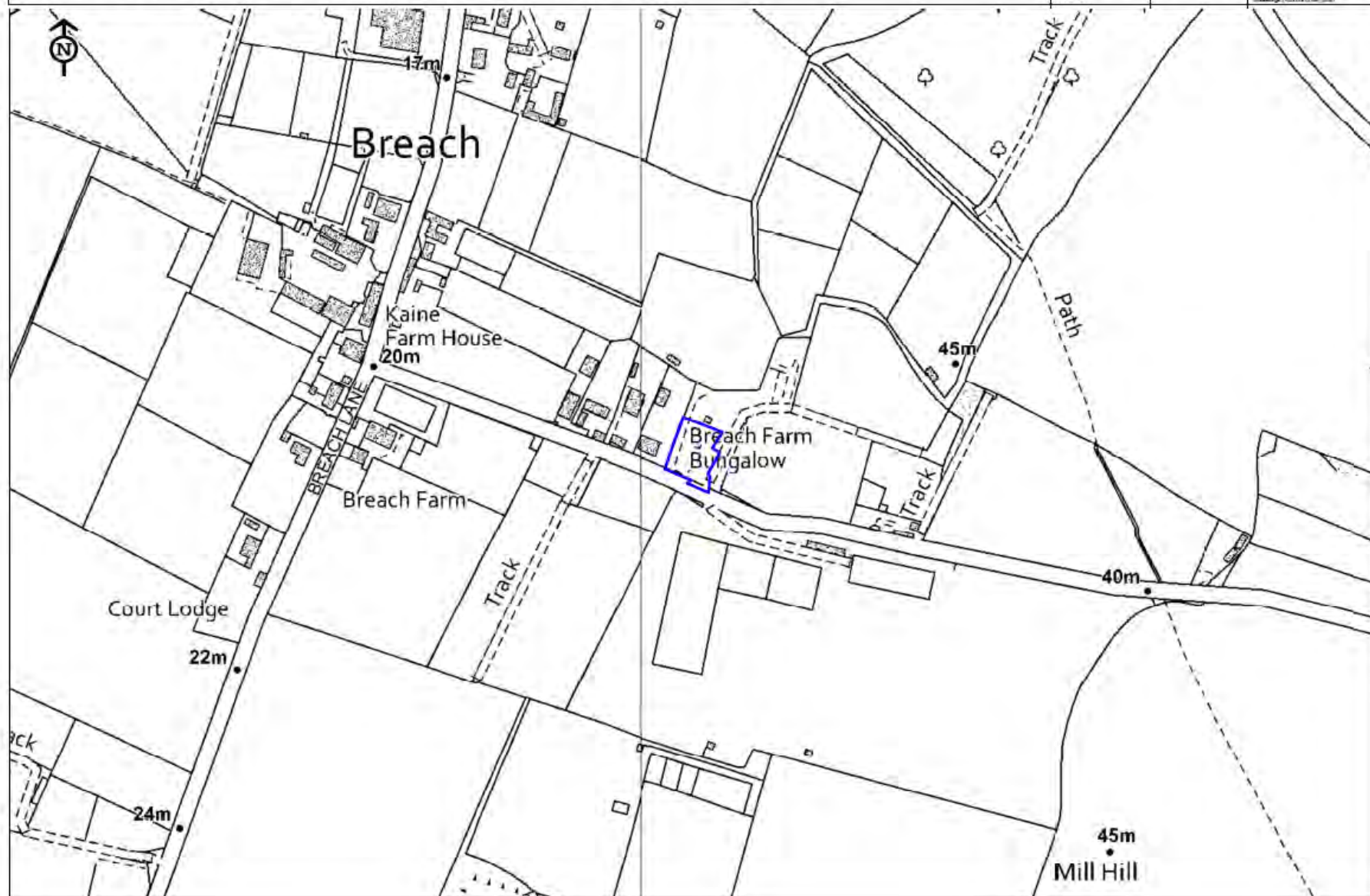

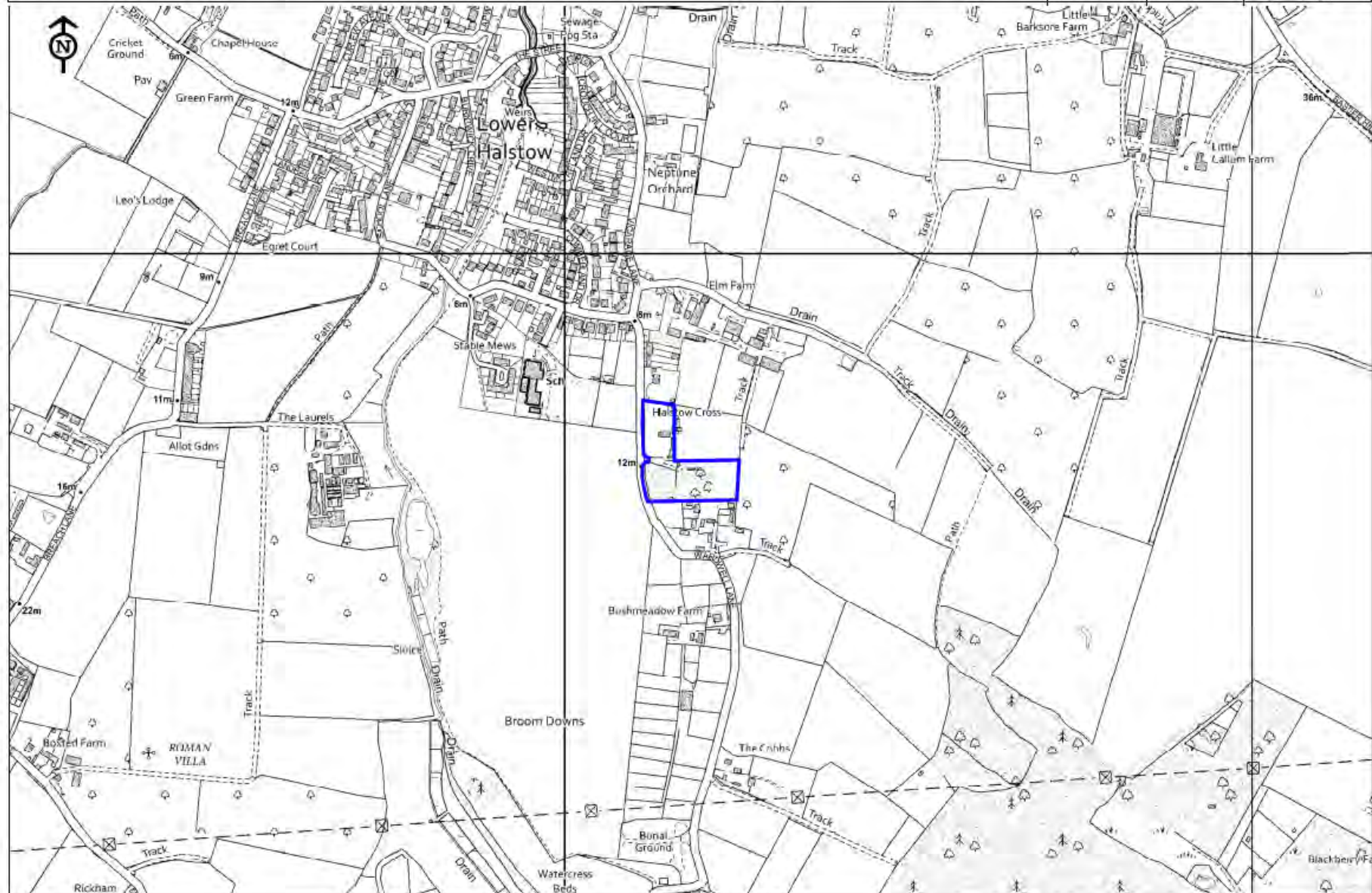


SHELAA/429 - Halstow Cross, Lower Halstow

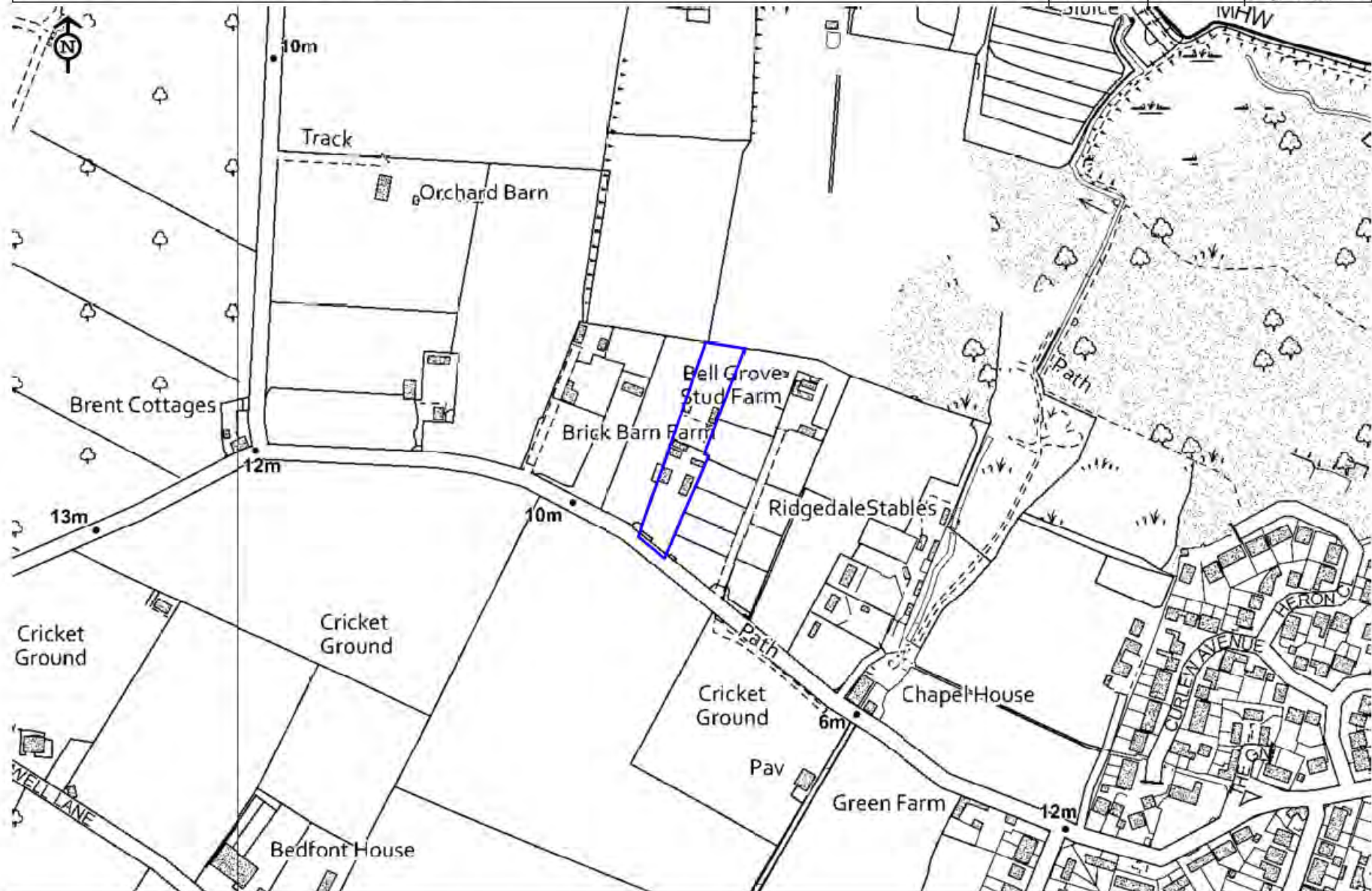
